

# Uniform Bond Schedule (Revised)

## In accordance with AO 2-49.9

Effective 01/01/2024

### NO BOND BEFORE FAH

1. Any new arrest in which the defendant already has an **open case** (PTR, PROB, COMMUNITY CONTROL) – First Appearance is required
2. **Any sex offender** arrested on any new charge (not including warrants with bond amounts)
3. Any violation of an injunction
4. Any new arrest in which the defendant is currently under supervision (Parole Commission, Conditional Release)
5. **Any career offender** or violent offender (identify this via the QP)
6. Any person arrested three (3) or more times in a six (6) month period ( PTR services to determine this)
7. The defendant's current offense is one of the following crimes:
  - a. Capital felony, Life felony, or **any felony of the 1<sup>st</sup> or 2<sup>nd</sup> Degree (This means that ALL 1<sup>st</sup> and 2<sup>nd</sup> degree felonies are no bond before FAH)**
  - b. Any homicide or attempted homicide solicitation to homicide or conspiracy to commit homicide
  - c. Assault in furtherance of a riot
  - d. Aggravated riot
  - e. Felony battery
  - f. DV battery by strangulation
  - g. **ANYTHING domestic violence**
  - h. Stalking, including cyberstalking
  - i. Intimidation
  - j. Assault or battery on a LEO, probation officer, detention staff member, including health services personnel
  - k. Assault or battery on a person 65 years of age or older
  - l. Robbery
  - m. Burglary
  - n. Carjacking
  - o. Resisting arrest with violence
  - p. Kidnapping
  - q. False imprisonment
  - r. Human trafficking
  - s. Human smuggling
  - t. Possession of firearm or ammunition by a convicted felon
  - u. Sexual battery
  - v. Indecent exposure

## NO BOND BEFORE FAH Continued.....

- w. Lewd / Lascivious behavior
- x. Exposure of sex organs
- y. Luring or enticing a child
- z. Child pornography
- aa. Abuse, neglect, or exploitation of an elderly or disabled person
- bb. Child abuse
- cc. Anything aggravated
- dd. Arson
- ee. Riot
- ff. Inciting a riot
- gg. Theft during a riot
- hh. Escape
- ii. Tampering or retaliating against a witness, victim, informant, or jury
- jj. Destruction of evidence
- kk. Any offense involving the interest of a criminal gang
- ll. Any trafficking offense
- mm. Racketeering
- nn. Failure to appear at required court proceedings while on bail
- oo. Conspiracy to engage in trafficking of controlled substance
- pp. Poisoning food or water
- qq. Abuse of a dead body
- rr. Treason
